

That the bid of International Business Machines Corporation is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 440,000 Original Utility Bills at a cost of \$8.86 per thousand, 50,000 First Overdue Bills at a cost of \$8.79 per thousand, and 40,000 Second Overdue Bills at a cost of \$8.79 per thousand, for a total cost of \$4,689.50, plus set-up charges of \$230.40; terms net 30 days plus sales tax.
