BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Stanley Andrews Sporting Goods, 2. Bill Smith Sporting Goods, and 3. Sportland, are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of ATHLETIC SUPPLIES, BALLS AND BASES, as may be required for a period of one (1) year beginning October 2, 1974 through October 1, 1975, per prices and escalation on file in the Purchasing Department, as follows:

1. Stanley Andrews Sporting Goods for Items 2, 5, 16 and 17; terms 2% 30 days, plus sales tax;
2. Bill Smith Sporting Goods for Items 7 and 11 through 15; terms 2% 30 days, plus sales tax;
3. Sportland for Items 1, 4 and 6; terms net 30 days, plus sales tax.
