RESOLUTION OF THE COUNCIL OF THE CITY OF SAN
DIEGO, CALIFORNIA, ORDERING CHANGES IN THE
ASSESSMENT AND IN THE INDIVIDUAL ASSESSMENTS
AND INCREASING THE AMOUNT OF THE CITY'S CASH
CONTRIBUTION

(Park District No. 12F - TECOLOTE CANYON)

WHEREAS, in proceedings under the San Diego Park District Procedural Ordinance of 1969 the Council adopted resolution of intention, Resolution No. 210795, ordering the City Manager to prepare the Report required by said Act, and pursuant thereto the City Manager has prepared said Report, consisting of a description of the property to be acquired for park and recreation purposes, an estimate of the cost and expense thereof, a diagram showing the assessment district, and a proposed assessment of the cost and expense of the proposed improvements, said Report being on file with the City Clerk; and

WHEREAS, the Council adopted Resolution No. 210796 approving said Report, as filed, and appointing the time and place of hearing thereon; and

WHEREAS, on July 18, 1974, the Council conducted a public hearing on said Report and heard all persons desiring to be heard thereon and in connection therewith, and following said public hearing the Council adopted Resolution No. 211118 overruling protests, confirming the assessment as set forth in said Report, ordering the acquisition referred to therein, and providing for the City's contribution, in cash and in City-owned

lands or lands being acquired by the City; and

WHEREAS, the amounts of certain individual assessments set forth in the assessment as approved and confirmed were in error, and should be corrected; and

WHEREAS, the City should increase the amount of its cash contribution to the extent that such corrections in said individual assessments result in the reduction thereof; and

WHEREAS, said corrections and changes can be effected without increasing the amount of the assessment or any individual assessments; and

WHEREAS, said corrections and changes may be made without notice or hearing as provided by Sections 10351 and 10352 of the Streets and Highways Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Council hereby orders that the assessment heretofore confirmed and approved, and the amounts of the individual assessments and the total amount of the assessment be and the same are hereby changed in accordance with Exhibit "A" of the "Schedule of Changes" attached hereto and made a part hereof, and the Superintendent of Streets is authorized and directed to change the assessment, and the amounts of the individual assessments, in conformance therewith.

2. The City Clerk is authorized and directed forthwith to mail corrected notices of assessments due and payable to the individual property owners affected by said changes.

3. The City cash contribution to the project is hereby ordered to be increased from \$2,336,261 to \$2,338,121.96.
