
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to exercise an option to purchase 10.3 acres of undeveloped land in the Serra Mesa area of San Diego, said option having been granted to the City of San Diego by Agreement between City and STADIUM VALLEY TOWN HOMES ASSOCIATES and UNITED JEWISH FEDERATION, a copy of which agreement is on file in the office of the City Clerk as Document No. 748611.

BE IT FURTHER RESOLVED, that the expenditure of \$72,500 from Environmental Growth Fund (2505) for the acquisition of the foregoing said land and related costs is hereby approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to reimburse to Environmental Growth Fund (2505) the \$72,500 expended pursuant to this resolution from proceeds from the sale of bonds for Sandrock Canyon Park Reserve District (Park District No. 13).
