
Adopted on OCT 31 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY, a corporation, executed in favor of The City of San Diego, bearing date of September 3, 1974, conveying to said City an easement and right of way for a public street and incidents thereto, through, over, under, along and across portions of Lots 439, 440, 441, 442 of Sunshine Gardens according to Map thereof No. 1804, filed in the Office of the County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named MARKET STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
