WHEREAS, a parking prohibition, as described hereinbelow, on the north side of Torrey Pines Road, between Princess Drive and La Jolla Shores Drive, will allow for the creation of a reserved area for bicyclists during periods of the day when bicyclists are most prevalent; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that parking be and it is hereby prohibited between the hours of 7:00 a.m. and 7:00 p.m., seven days a week, on the north side of Torrey Pines Road, between Princess Drive and La Jolla Shores Drive.

BE IT FURTHER RESOLVED, that Resolution No. 210518, adopted May 2, 1974, be and it is hereby rescinded.
