RESOLUTION DESIGNATING A COUNCIL MEMBER AND
CITY MANAGER AS LIAISON AND ALTERNATE LIAISON
TO THE LOCAL AGENCY FORMATION COMMISSION.

WHEREAS, the Local Agency Formation Commission is charged with the responsibility to review proposals affecting governmental organizations and political boundaries; and

WHEREAS, actions of the Local Agency Formation Commission affect The City of San Diego; and

WHEREAS, a need exists for The City of San Diego to more effectively assist the Commission when reviewing proposals that directly and indirectly affect The City of San Diego; and

WHEREAS, such assistance can be best rendered if a member of the Council of The City of San Diego and an alternate is designated to perform the function of liaison with the Commission; and

WHEREAS, the City Manager or his designated representative should be the alternate liaison to the Local Agency Formation Commission; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor is directed to appoint a member of the Council as liaison with the Local Agency Formation Commission.
2. That the City Manager or his designated representative is denominated the alternate liaison with the Local Agency Formation Commission.
