

RESOLUTION NO. 211960

WHEREAS, the residents of the Greater Golden Hills community, being that area of San Diego bounded by Interstate 5 on the west, State Highway 94 on the south, State Highway 15 on the east, Grape Street and Russ Boulevard on the north, and 28th Street on the northwest, such areas coinciding with that of the Golden Hills community, desire this area to be included in a recognized community plan; and

WHEREAS, there presently exists within this described area a resident/property owner general membership, with an elected executive board representing a cross-section of the area, civic, social, business and neighborhood organizations, and tenant, resident and non-resident property owner, commercial and other ownerships, thus meeting the representation requirements of Council Policy 600-5; and

WHEREAS, the residents of the Greater Golden Hills Community have requested formal recognition as the Greater Golden Hills Planning Association, and also request the services of the City Planning Department in the development of a community plan for the Greater Golden Hills area; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Greater Golden Hills Planning Association be, and is hereby authorized to represent the Greater Golden Hills

community and to work as a subcommittee of both Southeast San Diego Development Committee and the Park North-East Association, with the City Manager's office and the Planning Department, in the development of a long-range community plan consistent with community goals and objectives, and be responsible for its presentation as well as the coordination of community support for its adoption and effectuation.

2. That the Planning Department is directed to provide, as work load permits, the requested assistance in developing a community plan for the Greater Golden Hills community.
