2. That the expenditure of \$22,700.00 is hereby authorized out of Gas Tax Funds (Fund No. 220) of the City of San Diego and that the expenditure of \$2,150.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF RUFFIN ROAD FROM SUCCESS AVENUE TO AERO DRIVE in the City of San Diego, and related costs.
