That the bid of \$33,442.00 by Select Electric, Inc., a corporation, for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF CLEVELAND AVENUE AND WASHINGTON STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 748342.
2. That the expenditure of \$43,100.00 is hereby authorized out of Gas Tax Funds (Fund No. 220) of the City of San Diego and that the expenditure of \$5,400.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF CLEVELAND AVENUE AND WASHINGTON STREET in the City of San Diego, and related costs.
