BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$77,777.00 by Alvin Clancy Construction Co. and Alvin Clancy, a Joint Venture, for CONSTRUCTION OF AZALEA PARK - PHASE II, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 748343.
2. That the expenditure of \$46,300.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego, that the expenditure of \$52,000 is hereby authorized out of Park and Recreation Bond Fund (Fund No. 725) of the City of San Diego, and that the expenditure of \$500.00 is hereby authorized out of General Revenue Sharing Fund (Fund No. 2384) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF AZALEA PARK - PHASE II in the City of San Diego, and related costs.
