WHEREAS, the United States Department of Agriculture, U. S. Forest Service, is in the process of acquiring right of way in connection with a proposed 20-foot wide access road into the Cleveland National Forest; and

WHEREAS, a portion of said right of way crosses a portion of Sections 2 and 11, Township 12 South, Range 1 East, San Bernardino Base and Meridian, owned by The City of San Diego, and said United States of America desires to purchase said City-owned property for said right of way purposes; and

WHEREAS, the purpose for which the easement is required is a public purpose; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code and \$100 has been received from the United States Government to be deposited to the Utilities Capital Outlay Fund, Fund 246; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and


WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said right of way be conveyed to the United States of America in the public interest;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed of easement, the form of which is on file in the office of the City Clerk as Document No. 749310, conveying to the UNITED STATES OF AMERICA, an easement for right of way purposes across a portion of Section 2 and Section 11, Township 12 South, Range 1 East, S.B.B.M., as more particularly described in said deed of easement.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director of said City for further handling.
