
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to execute a First Amendment to Agreement with LEGAL AID SOCIETY OF SAN DIEGO COUNTY, INC., to amend the Model Cities Legal Services Project agreement, on file in the office of the City Clerk as Document No. 748561, pursuant to the terms and conditions set forth in the form of First Amendment to Agreement on file in the office of the City Clerk as Document No. 749295.

BE IT FURTHER RESOLVED, that the expenditure of \$119,000, \$32,000 of which was previously authorized by Resolution No. 210857 for the months of July and August, 1974, is hereby authorized out of Model Cities Fund 2904 of The City of San Diego, solely and exclusively, for the purpose of providing funds for the operation of the above-mentioned project.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized to transfer \$83,727 from the Revenue Sharing Trust Fund to Model Cities Fund 262 for further funding of the above-mentioned project as approved by the City/County Human Care Services Policy Committee on August 12, 1974.
