That the expenditure of \$138,000.00 is hereby authorized out of the Park and Recreation Bond Fund (Fund No. 725) and that the expenditure of \$125,000.00 is hereby authorized out of the Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for REMODEL OF LA JOLLA RECREATION CENTER in the City of San Diego, and related costs.
