APPROVING MAP OF THE PEPPER TREE COMPANY
SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


Said Council hereby finds that that certain map surveyed by RAYMOND F. HALL, JR., Registered Civil Engineer, entitled, "THE PEPPER TREE COMPANY Being a subdivision of a portion of Pueblo Lot 1110, in the City of San Diego, County of San Diego, State of California, according to Map of the Pueblo Lands of San Diego, made by James Pascoe in the year 1870, a copy of which said Map was filed in the office of the Recorder of San Diego County, November 14, 1921 and is known as Miscellaneous Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: portion of Camino Del Rio South, for public purposes, and said portion of street is hereby declared to be portion of a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as

heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
