That the acceptance by the City Manager of that deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of November 27, 1974, conveying to said City Lot 181 of Park Ridge Unit No.4 according to Map thereof No. 6825 recorded January 25, 1971, as File No. 1478 in the office of the County Recorder of San Diego County, for park purposes, be and the same is hereby approved.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.

BE IT FURTHER RESOLVED, that the expenditure of \$66,325.82 from Capital Outlay 245 Fund and \$75,949.18 from Park District Fund 11372, for a total of \$142,275, for the purpose of acquiring the above land for San Carlos Park, be and the same is hereby authorized and approved.
