

RESOLUTION No. 212266

Adopted on DEC 26 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

R75-1345

That the bids of 1. J.E. Bauer Coatings, Division of Whittaker Corporation and 2. Pervo Paint Company are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of TRAFFIC PAINT as may be required for a period of two (2) years beginning January 1, 1975 through December 31, 1976 as follows:

1. J.E. Bauer Coatings, Division of Whittaker Corporation, for Item 1 at a cost of \$4.08 per gallon and Item 2 at a cost of \$3.98 per gallon; terms net 30 days, plus sales tax, prices subject to escalation not to exceed 12% of bid prices, with an option to renew for an additional one (1) year period, during which prices are subject to escalation not to exceed 18% of bid prices.

2. Pervo Paint Company for Item 3 at a cost of \$4.74 per gallon and Item 4 at a cost of \$4.64 per gallon; terms $\frac{1}{2}$ % 30 days, plus sales tax, prices subject to escalation not to exceed 15% of bid prices, with an option to renew for an additional one (1) year period during which prices are subject to escalation not to exceed 9% of bid prices.
