
Adopted on DEC 26 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work to (1) install one double arm ornamental safety light on Palm Avenue, 800 feet westerly of 16th Street, and to underground the traffic signal and safety lighting service at 16th Street and Palm Avenue, and (2) underground the street lighting service at Paradise Valley Road-Meadowbrook Drive, and to provide 40 feet of trench for Pacific Telephone line in to the Skyline Hills Branch Library, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$4,800 from Capital Outlay Fund 245 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for this purpose and related costs.
