APPROVING THE MAP OF TIERRASANTA BAPTIST CHURCH

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, entitled "TIERRASANTA BAPTIST CHURCH Being a subdivision of a portion of Lot 29 of Rosedale Tract, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 825, filed in the office of the County Recorder of San Diego County, January 21, 1897, together with a portion of Tierrasanta Boulevard as dedicated to public use, also a portion of unnamed street between Lot 25 and Lot 29 of Rosedale Tract as closed and vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Baroque Lane, Ducos Place and a portion of Tierrasanta Boulevard for public purposes, and said streets and portion of a street are hereby declared to be public streets and portion of a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public

streets and portion of a public street are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
