WHEREAS, the Public Facilities and Recreation Committee of The City of San Diego has considered the proposed Memorandum of Understanding with the San Diego Unified School District for a cooperative effort in the area of education and recreation; and

WHEREAS, the Public Facilities and Recreation Committee has recommended the approval of the Memorandum of Understanding with the understanding that the City Manager will prepare an amendment requesting the San Diego Unified School District to concur in earmarking the \$357,000 contingency fund for swimming pools; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be, and he is hereby authorized to execute, for and on behalf of said City, the proposed Memorandum of Understanding with the SAN DIEGO UNIFIED SCHOOL DISTRICT for a cooperative effort in the area of education and recreation, pursuant to the terms and conditions set forth in the form of Memorandum of Understanding on file in the office of the City Clerk as Document No. 750762, with the added provision to said Memorandum of Understanding that the \$357,000 contingency fund be used, solely and exclusively, for construction of swimming pools.
