
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized to obtain authorization from the Department of Housing and Urban Development to incur costs for previously approved Model Cities projects from the 10% advance of the Community Development Block Grant.

BE IT FURTHER RESOLVED, that the City Manager is authorized to allocate existing Model Cities funds to the Community Development Block Grant fund for the purpose of funding approved Model Cities projects until such time as advance funds are received from H.U.D.
