WHEREAS, The City of San Diego has, by Resolution No. 212090 dated November 26, 1974, authorized the filing of a grant application in the amount of \$9,151,000 for Community Development Block Grants pursuant to the provisions of Title I, Housing and Community Development Act of 1974; and

WHEREAS, at the time of the approval of said application by this City Council, State and local clearinghouse comments pursuant to the provisions of OMB Circular No. A-95 had not been received; and

WHEREAS, said comments have now been received and have been filed in the office of the City Clerk as Documents Nos. 749723 and 749724, respectively; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this City Council has considered the comments contained in Documents Nos. 749723 and 749724 and hereby directs the City Manager to provide the State Office of Planning and Research and any other appropriate agency of the State with additional information in order that the description of the Block Grant projects may be more certain.

2. That the City Manager is hereby directed to forward said clearinghouse comments, State and CPO and any necessary amendments

to the United States Department of Housing and Urban Development pursuant to the provisions of the Housing and Community Development Act of 1974 and the regulations issued pursuant thereto.
