AN ORDINANCE AMENDING ORDINANCE NO. 11348 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY ESTABLISHING CAPITAL IMPROVEMENTS PROGRAM #29-269 ENTITLED "COWLES MOUNTAIN PARK LAND ACQUISITION" AND TRANSFERRING THE NECESSARY MONIES WITHIN THE CAPITAL OUTLAY FUND 245.

WHEREAS, the County of San Diego has negotiated for the immediate purchase of certain property currently in private ownership consisting of approximately 1,300 acres in the Cowles Mountain area; and

WHEREAS, it is proposed that said property be acquired for park and recreation purposes to serve both residents of the City and County of San Diego; and

WHEREAS, City desires to acquire an undivided one-half interest in said property and in consideration of the undivided one-half interest desires to reimburse County for one-half of its costs of acquisition; and

WHEREAS, it is now necessary to transfer funds within Capital Outlay Fund 245 to defray costs involved in said acquisition;

NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11348 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended to amend that portion relating to the Capital Improvements Program by transferring the sum of \$1,105,000.00 within the Fiscal 1975 Capital Outlay Fund 245 from the Tijuana Flood Control Right-of-Way Reserve to the Cowles Mountain Park Land Acquisition Fund, hereby established and identified as Capital Improvements Program #29-269.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its adoption.


