AN ORDINANCE REPEALING ORDINANCE NO. 9708 (NEW SERIES) CONCERNING RESTRICTIONS ON USE OF FEDERAL FUNDS FOR URBAN RENEWAL PROJECTS AND RESOLUTION NO. 190326 ESTABLISHING COUNCIL POLICY NO. 700-20 RELATING TO THE SAME SUBJECT


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 9708 (New Series), adopted October 24, 1967, limiting the use of federal funds for urban renewal to public projects be, and the same is hereby repealed.

Section 2. That Resolution No. 190326, adopted May 9, 1967, promulgating Council Policy No. 700-20 limiting as a matter of policy federal funds for urban renewal to public projects be, and the same is hereby repealed.

Section 3. This ordinance shall take effect and be in force on the 30th day from and after its passage.
