AN ORDINANCE AMENDING ORDINANCE NO. 11348 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 746519, AS ADOPTED AND AMENDED THEREIN, RELATING TO THE POSITION AND SALARY SCHEDULE FOR THE PARK AND RECREATION DEPARTMENT, PARK DIVISION DEPARTMENT 26.00, FUND 100.

WHEREAS, a recently completed Park Division audit proposed the establishment of a separate Park Design Division within the Park and Recreation Department; and

WHEREAS, the Public Facilities and Recreation Committee of the City Council approved said proposal on December 9, 1974; and

WHEREAS, this proposal will result in a net savings to the City of approximately \$55,776 in salaries and wages for the remainder of fiscal year 1974-75; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11348 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended to amend that portion of the Position and Salary Schedule for the Park and Recreation Department, Park Division, Department 26.00, Fund 100, to reflect and authorize the addition and deletion of the following personnel:
