AN ORDINANCE CREATING AND DECLARING THE LA JOLLA WOMAN'S CLUB PROPERTY AT 715 SILVERADO STREET TO BE AN HISTORIC ZONE.

WHEREAS, on March 2, 1973, the Historical Site Board of The City of San Diego designated the La Jolla Woman's Club property at 715 Silverado Street, also known as 7769 Draper Avenue, as Historical Site No. 79; and

WHEREAS, the La Jolla Woman's Club property was placed on the National Register of Historical Places on November 5, 1974; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That, pursuant to Section 50280 of the Government Code of the State of California, Lots 1 through 6, Block 32, La Jolla Park, Map 352, commonly known as 715 Silverado Street and also known as 7769 Draper Avenue, having been determined to be a qualified historical property as described in Article 3, commencing with Section 5031 of Chapter 1 of Division 5 of the Public Resources Code, is hereby declared to be an historic zone.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
