AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY AREA, LOCATED SOUTH OF ADAMS AVENUE, WEST OF 30TH STREET, NORTH OF EL CAJON BOULEVARD, AND EAST OF PARK BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A AND R-3 ZONES, AS DEFINED BY SECTIONS 101.0412 AND 101.0411, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12889, APPROVED JULY 7, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Park North-East

Community Area, located south of Adams Avenue, west of

30th Street, north of El Cajon Boulevard, and east of Park

Boulevard, in the City of San Diego, California, within the

boundaries of the districts designated "R-3A" and "R-3" on

Zone Map Drawing No. C-417.2, filed in the office of the

City Clerk as Document No. 750247, be, and it is hereby in
corporated into the R-3A and R-3 Zones as such zones are described

and defined by Sections 101.0412 and 101.0411, respectively, of

the San Diego Municipal Code.

Section 2. That Ordinance No. 12889, approved July 7, 1930, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.
