AN ORDINANCE OF THE CITY OF SAN DIEGO  
CONSENTING TO THE TRANSFER OF THE NON-  
EXCLUSIVE RIGHT, PRIVILEGE AND FRANCHISE  
TO LAY AND USE LINES, WIRES, COAXIAL  
CABLE AND APPURTENANCES FOR TRANSMITTING,  
DISTRIBUTING AND SUPPLYING RADIO AND  
TELEVISION ANTENNA SERVICE ALONG, ACROSS  
AND UPON THE PUBLIC STREETS, WAYS, ALLEYS  
AND PLACES WITHIN THE CITY OF SAN DIEGO  
KNOWN AS THE TIERRASANTA AREA FROM  
TIERRASANTA CABLE TV ASSOCIATION TO  
MISSION CABLE TV, INC.

WHEREAS, The City of San Diego has by Ordinance No. 10501  
(N.S.) granted the nonexclusive right, privilege and franchise  
to lay and use lines, wires, coaxial cable and appurtenances  
for transmitting, distributing and supplying radio and tele-  
vision antenna service along, across and upon the public streets,  
ways, alleys and places within the City of San Diego known as  
the Tierrasanta area to Tierrasanta Cable TV Association, as  
more particularly set forth in said ordinance; and

WHEREAS, Tierrasanta Cable TV Association has by a letter  
dated December 27, 1974, a copy of which is on file in the office  
of the City Clerk as Document No. 750051, requested The City of  
San Diego to consent to the transfer of said franchise to  
Mission Cable TV, Inc. pursuant to the provisions of Section 8  
of Ordinance No. 10501 (N.S.); NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego  
as follows:


