AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE, BY ADDING DIVISION 24, PLANNING DEPARTMENT, AND SECTION 22.2401, PLANNING DEPARTMENT - POWERS AND DUTIES OF THE PLANNING DIRECTOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, of the San Diego
Municipal Code, be amended by adding Division 24, Planning
Department, and Section 22.2401, Planning Department - Powers and
Duties of the Planning Director, to read as follows:

#### DIVISION 24

## PLANNING DEPARTMENT

SEC. 22.2401 PLANNING DEPARTMENT - POWERS AND DUTIES
OF THE PLANNING DIRECTOR

The Planning Department is a City department. The Director is the administrative head of the department and shall be appointed by the City Council. The Planning Director may be removed by the Council. The Director, under the direction of the Planning Commission, shall:

- a. Be responsible for all activities of the Planning Department as established by City Council, Planning Commission and State and Federal laws and regulations.
- b. Provide professional planning guidance in the preparation and maintenance of a comprehensive

- c. Organize the Planning Department to carry out all assigned functions.
- d. Select, train and evaluate the work of principal subordinates to implement City Council policies and ordinances.
- e. Serve as technical adviser to the City

  Review Boards.
- f. Coordinate Planning Department activities
  with the City Manager and City departments, other
  municipal governments, the Comprehensive Planning

- g. Serve as the chief planner representative of the Mayor and Council to other governmental agencies and officers.
