AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING DIVISION 22, SECTIONS 22.2201 AND 22.2202; BY AMENDING SECTION 22.1801; AND BY ADDING TO DIVISION 24, SECTION 22.2402; SAID CHANGES EFFECTING THE TRANSFER OF THE FUNCTIONS OF THE ENVIRONMENTAL QUALITY DEPARTMENT TO THE PLANNING DEPARTMENT AND CREATING THEREIN THE ENVIRONMENTAL QUALITY DIVISION.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2 of the San Diego Municipal Code be and the same is hereby amended by repealing Division 22, Sections 22.2201 and 22.2202.

Section 2. That Chapter II, Article 2 of the San Diego Municipal Code be and the same is hereby amended by amending Section 22.1801 to read as follows:

SEC. 22.1801 CITY DEPARTMENTS

a. Purpose and Intent. It is the purpose and intent of the City Council to enumerate the existing departments of the City because of repeated reference in City legislation and operation to such departments.

b. The following are the departments of the City of San Diego within the meaning of the Charter and ordinances of said City:

c. The department head for each department of City Council--Districts 1 through 8 shall be the duly elected and/or appointed Councilman or Councilwoman from the district.

Section 3. That Chapter II, Article 2 of the San Diego Municipal Code be and the same is hereby amended by adding to Division 24, Section 22.2402 to read as follows:

**SEC. 22.2402 ENVIRONMENTAL QUALITY DIVISION**

a. In addition to such divisions in the Planning Department as exist from time to time by virtue of the Budget, Annual Appropriation Ordinance, and other ordinances of the City, there is hereby created as a division of the Planning Department the Environmental Quality Division. The head of the division shall be responsible for conducting reviews

and making determinations as to the environmental significance of proposed projects or activities under and pursuant to guidelines set forth in appropriate ordinances, regulations, standards and procedures of The City of San Diego. The division under his supervision shall also conduct those activities, prepare appropriate reports and perform such services as set forth and required by the Environmental Impact Report Procedural Ordinance, Chapter VI, Article 9, Section 69.0101 et seq. of this Code. Any reference as is contained in said Article 9 of this Code to the Director of the Environmental Quality Department and the department itself shall hereafter be read as if it applies to the head of the Environmental Quality Division of the Planning Department and the division itself.

b. The Environmental Quality Division of the Planning Department shall establish and maintain that degree of independence in the performance of its functions and duties as will assure the Council and the people of the City of San Diego that its review and analysis of the environmental consequences of projects under its purview, whether beneficial or detrimental, are independent and wholly objective and are not prepared for the purpose of either supporting or detracting from any project, plan or position,

whether advanced by the City, the Planning Department  
itself, any other governmental agency, a developer,  
a citizen or a group of citizens.

Section 4. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
