AN ORDINANCE AMENDING ORDINANCE NO. 11331 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1974-75," BY AMENDING EXHIBIT C THEREOF TO DELETE THE UNCLASSIFIED POSITIONS OF ENVIRONMENTAL QUALITY DIRECTOR AND ASSISTANT ENVIRONMENTAL QUALITY DIRECTOR.

WHEREAS, the Council has adopted an ordinance deleting the Environmental Quality Department as a department of The City of San Diego and transferring the functions of said former Environmental Quality Department to the Planning Department, creating therein a new division to be known as the "Environmental Quality Division"; and

WHEREAS, it is now necessary, as companion legislation, to amend the appropriate table of position titles in the Executive category of the Unclassified Service to reflect the deletion of the unclassified positions of Environmental Quality Director and Assistant Environmental Quality Director; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 11331 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1974-75," be and the same is hereby amended by

amending Exhibit C thereto to delete the unclassified position titles of Environmental Quality Director from Classification Range, Executive III, and Assistant Environmental Quality Director from Classification Range, Executive II.
