AN ORDINANCE INCORPORATING THAT PROPERTY IN THE STATE UNIVERSITY AREA GENERALLY LOCATED ALONG MONTEZUMA ROAD, BOUNDED ON THE WEST BY 55TH STREET, AND ON THE EAST BY THE R-3 ZONED PARCEL FACING MONTEZUMA ROAD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the State University Area generally located along Montezuma Road, bounded on the west by 55th Street, and on the east by the R-3 zoned Parcel facing Montezuma Road, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-429.1, filed in the office of the City Clerk as Document No. 749986, be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That the following Ordinances of The City of San Diego, be, and they are hereby repealed insofar as they conflict herewith:
