'AN ORDINANCE INCORPORATING THAT PROPERTY IN THE STATE UNIVERSITY AREA LOCATED ALONG MONTEZUMA ROAD, BETWEEN CATOCTIN DRIVE AND EL CAJON BOULEVARD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8989 (NEW SERIES), ADOPTED MARCH 26, 1964, ORDINANCE NO. 8666 (NEW SERIES), ADOPTED JUNE 28, 1962, ORDINANCE NO. 7076 (NEW SERIES), ADOPTED JULY 26, 1956, AND ORDINANCE NO. 9294 (NEW SERIES), ADOPTED OCTOBER 7, 1965, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the State University Area located along Montezuma Road, between Catoctin Drive and El Cajon Boulevard, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-430.1, filed in the office of the City Clerk as Document No. 749985, be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8989 (New Series), adopted March 26, 1964, Ordinance No. 8666 (New Series), adopted June 28, 1962, Ordinance No. 7076 (New Series), adopted July 26, 1956, and Ordinance No. 9294 (New Series), adopted October 7, 1965, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.
