AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN LAND IN THE PACIFIC BEACH AREA IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "PACIFIC BEACH RECREATION CENTER."

WHEREAS, The City of San Diego is the owner of certain land in the Pacific Beach area in the City of San Diego; and

WHEREAS, it is the desire of the people of The City of San Diego to set aside and dedicate forever portions of said land, hereinafter described, for public use and enjoyment as and for a public park to be used by all the public for park and recreational purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be, and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "PACIFIC BEACH RECREATION CENTER."

Section 3. That the real property so dedicated and named is described as follows:

Lots 1 through 10 and 31 through 40, Block 162, Pacific Beach, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 916, filed in the Office of the County Recorder on April 17, 1905, together with alley closings adjacent.


