AN ORDINANCE INCORPORATING THAT PROPERTY IN THE STATE UNIVERSITY AREA LOCATED EAST OF EL CERRITO BOULEVARD, SOUTH OF ADAMS AVENUE, NORTH OF EL CAJON BOULEVARD, AND WEST OF THE EASTERLY LOT LINE OF LOTS FACING 60TH STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13559, ADOPTED JULY 11, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the State University Area located east of El Cerrito Boulevard, south of Adams Avenue, north of El Cajon Boulevard, and west of the easterly lot line of lots facing 60th Street, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-432.2, filed in the office of the City Clerk as Document No. 750286, be, and it is hereby incorporated into &-3 Zone as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13559, adopted July 11, 1932, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as the same conflicts herewith.
