ORDINANCE NO. 11519 (New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE STATE UNIVERSITY AREA LOCATED GENERALLY SOUTH OF INTERSTATE 8, EAST OF HEWLETT DRIVE AND 55TH STREET, NORTH OF MONTEZUMA ROAD AND HARDY AVENUE, AND WEST OF EAST AND WEST FALLS VIEW DRIVE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE 13559, ADOPTED JULY 11, 1932, ORDINANCE NO. 3418 (NEW SERIES), ADOPTED MAY 13, 1947, ORDINANCE NO. 6535 (NEW SERIES), JUNE 9, 1955, AND ORDINANCE NO. 6557 (NEW SERIES), ADOPTED JUNE 23, 1955, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the State University Area located generally south of Interstate 8, east of Hewlett Drive and 55th Street, north of Montezuma Road and Hardy Avenue, and west of East and West Falls View Drive, in the City of San Diego, California, within the boundary of the district designated "R-1-5" on Zone Map Drawing No. C-429.1, filed in the office of the City Clerk as Document No. 749986, be, and it is hereby incorporated into R-1-5 Zone as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13559, adopted July 11, 1932, Ordinance No. 3418 (New Series), adopted May 13, 1947, Ordinance No. 6535 (New Series), adopted June 9, 1955, and Ordinance No. 6557
