AN ORDINANCE INCORPORATING A PORTION OF LOT 12, JOSEPH REINER'S SUBDIVISION OF PUEBLO LOT 1103, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 1947 (NEW SERIES), ADOPTED OCTOBER 1, 1940 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot 12, Joseph Reiner's Subdivision of Pueblo Lot 1103, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-2834, filed in the office of the City Clerk under Document No. 750099, be, and it is hereby incorporated into CO Zone, as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.

Section 2. That Ordinance No. 1947 (New Series), adopted October 1, 1940, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
