AN ORDINANCE AMENDING CHAPTER X, ARTICLE 2,  
DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE,  
BY ADDING SECTION 102.0205.1, APPEAL BY  
PERSONS ADVERSELY AFFECTED.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter X, Article 2, Division 2, of the  
San Diego Municipal Code, be amended by adding Section 102.0205.1  
to read as follows:

SEC. 102.0205.1 APPEAL BY PERSONS  
ADVERSELY AFFECTED

All rights of appeal to the Council accorded  
the subdivider with respect to a decision of the  
Subdivision Review Board or the Planning Commission  
shall be extended to any interested person adversely  
affected by such decision. The procedures shall be  
the same as set forth in Section 102.0205, paragraph 8.

Section 2. This ordinance shall take effect and be in force  
on the thirtieth day from and after its passage.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


