AN ORDINANCE AMENDING ORDINANCE NO. 11348 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY ESTABLISHING CAPITAL IMPROVEMENTS PROGRAM #54-626 ENTITLED "NIMITZ BOULEVARD."

WHEREAS, the City of San Diego has negotiated for the immediate purchase of certain property currently in private ownership consisting of approximately 2.26 acres in the area of Nimitz and Famosa Boulevards; and

WHEREAS, it is proposed that said property be acquired for street purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 11348 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended to amend that portion relating to the Capital Improvements Program by establishing Capital Improvements Program #54-626 to be entitled "NIMITZ BOULEVARD."

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
