AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY LOCATED SOUTH OF NORTH PARK WAY, WEST OF INTERSTATE 805, GENERALLY NORTH OF LANDIS STREET AND EASTERLY OF 30TH STREET INCLUDING LOTS ON BOTH SIDES OF RAY STREET BETWEEN NORTH PARK WAY AND MYRTLE AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12820, APPROVED APRIL 28, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That property in the Park North-East Community located south of North Park Way, west of Interstate 805, generally north of Landis Street and easterly of 30th Street including lots on both sides of Ray Street between North Park Way and Myrtle Avenue, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-420.1, filed in the office of the City Clerk as Document No. 749492, be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.


