AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY AREA, LOCATED SOUTH OF EL CAJON BOULEVARD AND NORTH OF UNIVERSITY AVENUE, BETWEEN PARK BOULEVARD AND INTERSTATE 805, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12889, APPROVED JULY 7, 1930, AND ORDINANCE NO. 12820, APPROVED APRIL 28, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Park North-East Community Area, located south of El Cajon Boulevard and north of University Avenue, between Park Boulevard and Interstate 805, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No.C-418.1, filed in the office of the City Clerk as Document No. 749432, be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12889, approved July 7, 1930, and Ordinance No. 12820, approved April 28, 1930, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
