AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY AREA, GENERALLY LOCATED BETWEEN MISSION VALLEY ON THE NORTH, INTERSTATE 805 ON THE EAST, ADAMS AVENUE ON THE SOUTH, AND TEXAS STREET ON THE WEST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0410 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Park North-East Community Area, generally located between Mission Valley on the north, Interstate 805 on the east, Adams Avenue on the south, and Texas Street on the west, in the City of San Diego, California, within the boundaries of the districts designated "R-2A" and "R-2" on Zone Map Drawing No. C-416.1, filed in the office of the City Clerk as Document No. 749433, be, and it is hereby incorporated into R-2A and R-2 Zones, as such zones are described and defined by Sections 101.0410 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That the following ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith:
