AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY AREA, GENERALLY LOCATED EAST OF PARK BOULEVARD, SOUTH OF UNIVERSITY AVENUE, WEST OF ALABAMA STREET, AND NORTH OF BALBOA PARK, KNOWN AS FLORIDA STREET CANYON, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3A ZONE, AS DEFINED BY SECTION 101.0412 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12988, APPROVED OCTOBER 20, 1930, AND ORDINANCE NO. 12889, APPROVED JULY 7, 1930 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Park North-East Community Area, generally located east of Park Boulevard, south of University Avenue, west of Alabama Street, and north of Balboa Park, known as Florida Street Canyon, in the City of San Diego, California, within the boundary of the district designated "R-3A" on Zone Map Drawing No. C-419.1, filed in the office of the City Clerk as Document No. 749434, be, and it is hereby incorporated into R-3A Zone as such zone is described and defined by Section 101.0412 of the San Diego Municipal Code.


