

ORDINANCE NO. 11539
(New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY AREA, GENERALLY LOCATED ON THE NORTH HALF OF THE CITY BLOCKS BETWEEN ALABAMA STREET AND VILLA TERRACE AND SOUTH OF LANDIS STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12889, APPROVED JULY 7, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Park North-East Community Area, generally located on the north half of the City blocks between Alabama Street and Villa Terrace and south of Landis Street, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-419.1, filed in the office of the City Clerk as Document No. C-419.1, filed in the office of the City Clerk as Document No. 749434, be, and it is hereby incorporated into R-3 Zone as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12889, approved July 7, 1930, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.
