AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY LOCATED SOUTH OF DWIGHT STREET, WEST OF THE ALLEY BETWEEN BOUNDARY STREET AND NILE STREET, NORTH OF REDWOOD STREET, AND EAST OF 32ND STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12820, APPROVED APRIL 28, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That property in the Park North-East Community located south of Dwight Street, west of the alley between Boundary Street and Nile Street, north of Redwood Street, and east of 32nd Street, in the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing No. C-420.1, filed in the office of the City Clerk as Document No. 749492, be, and it is hereby incorporated into R-2 Zone as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12820, approved April 28, 1930, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.
