

ORDINANCE NO. 11544

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY LOCATED SOUTHERLY OF UPAS STREET, WESTERLY OF 30TH STREET, NORTH OF THORN STREET AND EASTERLY OF GRANADA STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0410 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12820, APPROVED APRIL 28, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Park North-East Community located southerly of Upas Street, westerly of 30th Street, north of Thorn Street and easterly of Granada Street, in the City of San Diego, California, within the boundary of the districts designated "R-2A" and "R-2" on Zone Map Drawing No. C-420.1, filed in the office of the City Clerk as Document No. 749492, be, and it is hereby incorporated into R-2A and R-2 Zones as such zones are described and defined by Sections 101.0410 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 12820, approved April 28, 1930, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.


