AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY LOCATED SOUTH OF REDWOOD STREET, WEST OF TAMARACK STREET, NORTH OF NUTMEG STREET, AND EASTERLY OF DALE STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12795, APPROVED APRIL 14, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Park North-East Community located south of Redwood Street, west of Tamarack Street, north of Nutmeg Street, and easterly of Dale Street, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-421.1, filed in the office of the City Clerk as Document No. 749493, be, and it is hereby incorporated into R-3 Zone as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12795, approved April 14, 1930, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
