AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY, LOCATED SOUTH OF KALMIA STREET, EAST OF BALBOA PARK, NORTH OF "A" STREET, AND BOUNDED BY DALE STREET FROM "A" STREET TO GRAPE STREET AND BY THE EASTERLY PROPERTY LINE OF LOTS FACING 29TH STREET FROM GRAPE STREET TO KALMIA STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3, R-2A AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0411, 101.0410 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 12795, APPROVED APRIL 14, 1930 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Park North-East Community, located south of Kalmia Street, east of Balboa Park, north of "A" Street, and bounded by Dale Street from "A" Street to Grape Street and by the easterly property line of lots facing 29th Street from Grape Street to Kalmia Street, in the City of San Diego, California, within the boundaries of the districts designated "R-3," "R-2A" and "R-2" on Zone Map Drawing No. C-422.3, filed in the office of the City Clerk as Document No. 750681, be, and it is hereby incorporated into R-3, R-2A and R-2 Zones, as such zones are described and defined by Sections 101.0411, 101.0410 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 12795, approved April 14, 1930, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
