AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY, LOCATED SOUTH OF THE ALLEY BETWEEN KALMIA STREET AND JUNIPER STREET, WEST OF 31ST STREET, NORTH OF GRAPE STREET, AND INCLUDES THE EASTERLY LOTS IN THE BLOCKS BETWEEN 29TH STREET AND DALE STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12795, APPROVED APRIL 14, 1930 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:


Section 1. That property in the Park North-East Community, located south of the alley between Kalmia Street and Juniper Street, west of 31st Street, north of Grape Street, and includes the easterly lots in the blocks between 29th Street and Dale Street, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-422.3, filed in the office of the City Clerk as Document No. 750681, be, and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12795, approved April 14, 1930, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.
