AN ORDINANCE INCORPORATING THAT PROPERTY IN THE PARK NORTH-EAST COMMUNITY, LOCATED SOUTH OF GRAPE STREET, WESTERLY OF EDGEMONT STREET, NORTH OF "A" STREET, AND EAST OF DALE STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 AND R-2A ZONES, AS DEFINED BY SECTIONS 101.0409 AND 101.0410, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12795, APPROVED APRIL 14, 1930 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Park North-East Community, located south of Grape Street, westerly of Edgemont Street, north of "A" Street, and east of Dale Street, in the City of San Diego, California, within the boundaries of the districts designated "R-2" and "R-2A" on Zone Map Drawing No. C-422.3 , on file in the office of the City Clerk as Document No. 750681 be, and it is hereby incorporated into R-2 and R-2A Zones, as such zones are described and defined by Sections 101.0409 and 101.0410, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 12795, approved April 14, 1930, of the Ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.
